## MEETING

# January 7pm 2024

Meeting started at 7 PM by Staceyann.

1. Review old minutes

## Link to December Minutes

Lu made the motion to approve the minutes. Courtney seconded. Motion passed.

- 2. Treasury report
  - a. checking: \$33,817.65b. CD's: \$16,236.65c. PayPal \$5067.25
    - D. Fall Competition report
    - E. Workers Fall State Competition
    - I. Audrey questioned the payments to make sure we are still under \$600 for the nonprofit status as discussed in April 2023.
    - II. Right now Sarah will be receiving more than \$600 due to her responsibilities of co-competition director, Coaches Day, and competitions.
      - a. Tax forms need to be sent if members do get paid more than \$600 per year.
      - b. If board members have a paid position for competition, they will not receive the \$50 stipend.
      - c. Mileage and hotel will not be considered in that \$600 per year payment.

- d. Sarah, Billie Ann, and Lu will not be paid the \$50 for competition moving forward, but they will need to include that in their taxes for 2023.
- e. Meal stipend for board members? Or just judges?
- 3. How many meetings per year, coaches day, competitions, for board attendance.
  - a. Also what is excused/unexcused absences
  - I. 75% of meetings need to be attended. (9 Zoom meetings per year), plus Coaches Day, Executive Board meeting, and competitions.
  - II. Jen L. suggested a total of 12 meetings to be required. If you miss 3 meetings, then that member will no longer be on the NDCCA board.
  - III. April is a required meeting for board members. Extenuating circumstances will be considered.
  - IV. Lu makes a motion to require 75% of all meetings (including Executive board meeting in April, Coaches Day, and competitions) are required of board members.
  - Jen L. seconded the motion. Motion passed.

- a. Communication is key. A case-by-case decision will be discussed by the president, vice president, and executive director after the board member notifies all three.

- 4. Winter competition updates
  - a. Romero, Sue, Jesse, and Amanda are available for Winter competition.
  - b. Tech timers and tech judges are pending.
    - i. Katie, Brandi, Dakia? Dakia offered her college athletes to help with some of this.
    - ii. Dakia offered to be available for the appeals process and some of her athletes to help with the tech table.
  - c. DSU showcase possibility- board feels this would be a nice addition for our high school athletes to see and for a ND program to get feedback to best represent us.
  - d. Plan is that the last group competes, DSU comes out and performs, mats will be rolled up, and then the parade of athletes will be introduced. Lastly, the award ceremony will begin.
  - e. If additional judges are needed, Dakia, Katie, and Leah will be

available.
